Antares High Growth Shares Fund



April 2021

Fund description and investment return objective

The Fund aims to outperform the S&P/ASX 200 Total Return Index (after fees) over rolling five year periods. The Fund seeks to enhance returns through a range of investment strategies including long/short positions and active trading, along with the ability to use exchange traded derivatives.

Fund commentary

The Antares High Growth Shares Fund delivered a return of 4.0% (net of fees) for the month of April 2021.¹

Australian shares made strong gains in April. The resource sector returned 5.4% boosted by the surge in commodity prices including iron ore (20%) and copper (13%). The information technology sector also performed well partly buoyed by strong results from the major global technology companies. Sectors posting declines included energy, on the back of the fall in the oil price, consumer staples and utilities.

Contributing to Fund performance were overweight positions in IGO Limited (IGO), Afterpay (APT) and Boral (BLD). IGO's March quarter report was well received by the market with confirmation that its lithium acquisition was on-track for completion in the June 21 quarter. The company also announced it had agreed to sell its 30% stake in the Tropicana Gold Mine asset to Regis Resources for approximately \$900m – regarded by some analysts as a premium price. Technology stocks were the strongest performers in April, in large part driven by the decline in Australian bond yields, which fell by approximately 10 basis points in April following a similar fall in March. APT released its 3Q21 update which revealed underlying sales were up by 123% in constant currency on 3Q20. The company also noted the successful launch and potential of its new European operations. BLD announced the sale of its 50% share in USG Boral for US\$1bn with proceeds to be used to fund a share buyback program.

Detracting value was a short position in Fortescue Metals (FMG) and overweight holdings in Incitec Pivot (IPL) and Woolworths (WOW). The iron ore price continued to rise in April taking the increase in the past year to 114%. As a pure iron ore play, FMG shares benefitted. The recommencement of operations at IPL's Waggaman ammonia plant was further delayed in April, with the company estimating a negative impact on EBIT in FY21 of \$36m. The company also revealed the costs of getting the plant operating were \$80m, adding further disappointment. Consumer staples lagged the market as retailers, including WOW, came up against very high Covid lockdown fuelled sales from the same period last year.

Australia's economic data continues to point to a promising year in 2021. Strong results for business and consumer sentiment surveys as well as healthy employment gains suggest that Australia's economic recovery has considerable momentum. Australia's 1.1% annual consumer inflation rate for the March quarter provides some comfort for the Reserve Bank to maintain low cash interest rates. Sporadic coronavirus cases appear to be containable and despite some reluctance in relation to take up of the Astra Zeneca vaccine, the vaccination rollout program continues.

Investment terms and guidelines

Short selling involves borrowing a share from a prime broker to sell to the market, with an agreement to purchase that share back at a later date. When the Fund short sells a share, we anticipate taking advantage of declines in the price of that share by selling the share at one price, and then aiming to buy back that share at a subsequent lower price. Short selling is limited to 25% of the value of the Fund's net assets.

Enhanced long positions refer to the shares in which the Fund holds the largest overweight positions when compared to its benchmark weighting. Long positions are limited to 125% of the value of the Fund's net assets. All long and short positions will be managed to provide investors with a gross exposure to the sharemarket of up to 150%, but the overall net exposure will be between 90 - 100%.

Active trading refers to trading in shares where the Fund has held a range of different positions over a relatively short period of time, with a view to fully exploiting all available opportunities to add value as market circumstances change. It may also involve simply managing an overweight or other position held - adding to or reducing the position to benefit from smaller movements in the share price.
