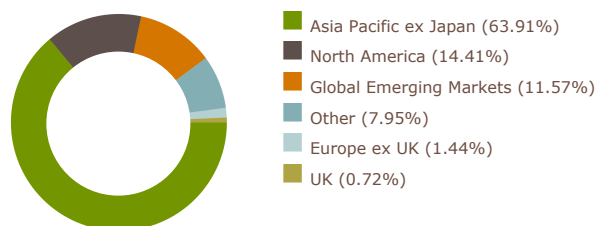

Country allocation



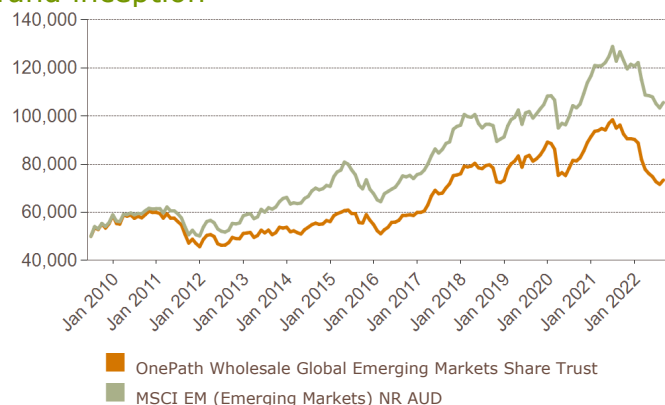

Market and portfolio review

Global emerging equity markets faced volatility during the quarter. The Fund underperformed the benchmark over the quarter due to a bias towards the underperforming China and Brazilian equities. This was predominantly driven by underlying managers, TT International and Berkeley Street.

Future investment strategy

The exposure to high quality companies with sustainable growth in emerging markets should bode well for the medium to longer term. It is anticipated these stocks will continue to perform during both a highly volatile period driven by higher inflation, as well through to the longer term.
