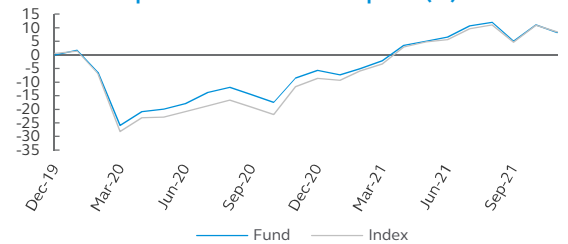

Fund management commentary**Market Review**

Ongoing inflation concerns and worsening COVID-19 trends kept markets sideling before the emergence of the Omicron variant drove a sharp selloff in equities towards month end. REITs (FTSE EPRA/NAREIT Developed NTR, -2.2%) tracked broader equities (MSCI World GTR, -2.2%), with both asset classes down despite flattening yield curves as investors were concerned that inflation would impact growth. Global bonds outperformed REITs and equities (Bloomberg Global Aggregate, -0.3%). The Americas was the most resilient region. Europe was weighed down by weakness on the Continent where infection rates continued to rise, resulting in tightened distancing restrictions and some countries announcing lockdowns. Asia was the weakest performer as stagflationary fears weighed heavily.

Fund Review

Emerging market exposure was a main detractor, as there continued to be concerns over the China property slowdown. Though government policy has shifted from tightening to stabilization, these supply side measures have been inadequate to stabilize demand. Underweight to U.S. malls was a drag on relative performance with the sector being a strong performer as retailers' earnings results have highlighted robust consumer spending amidst a strong October retail sales report. U.S. data centers and towers positioning detracted, driven by M&A activity. Overweights to strength in U.K. self-storage and U.K. and Australian industrial stocks were the main contributors.

Market Outlook

We are cautiously constructive on markets going forward but will continue to evaluate relative valuations as we expect that virus uncertainty and policy-induced volatility is likely here to stay. Rather than attempting to forecast sentiment shifts, our investment decisions are guided by fundamental valuation levels and we will continue to search for opportunities using our bottom-up, stock selection focused approach. We believe stocks with attractive earnings prospects and favorable structural demand drivers are best positioned, based on current valuation levels, to outperform in the intermediate to longer-term future. That said we do continue to look selectively for cyclical themes to add to after their underperformance against growth in the past quarter, particularly where we feel consensus has been too bearish and there is scope for earning upgrades given the potential for the business cycle to reassert itself as vaccination rates improve and lockdowns recede.
